1. Collection of personal data and controller

In accordance with current legislation on data protection, the user of this website is informed that the personal data provided through this website, as well as any other personal data that may be provided in the future, will be processed by BALONCESTO MÁLAGA, S.A.D. ("UNICAJA BALONCESTO"), with registered office at Avenida Gregorio Diego, 44, 29004 Málaga (Spain) and NIF A-29.575.933, with the following e-mail address for communication purposes: correo@unicajabaloncesto.com.

2. Purpose and legal basis of the processing of personal data

UNICAJA BALONCESTO informs you that your data will be processed for the following purposes:

1. Analysis of user interactions. UNICAJA BALONCESTO will process the data provided by you through the website, as well as your interactions on it. Specifically, the processing will allow us to analyse the user's browsing habits, enabling us to offer a more agile and personalised browsing experience, and to detect fraudulent use of the website.

Legal basis: the user's consent.

This consent may be withdrawn at any time so that your personal data is no longer processed by UNICAJA BALONCESTO, by sending an e-mail to the following address: correo@unicajabaloncesto.com.

2. Computer control of the website. UNICAJA BALONCESTO will process the data provided by the user through their browsing on the website, as well as their interactions on it, in order to detect any fraudulent use of the website or loss of information.

Legal basis: compliance with legal obligations of UNICAJA BALONCESTO in order to ensure the security of the website and the information contained therein, in accordance with article 12 bis of the LSSICE.

3. User's relationship with UNICAJA BALONCESTO. UNICAJA BALONCESTO will process the user's data in order to maintain, develop and fulfil its relationship with UNICAJA BALONCESTO derived from the contracting of any of the services it offers. Specifically, this processing consists of managing this contractual relationship, sending notifications, attending to requests and managing payments and invoicing.

Legal basis: The execution of the contractual relationship that the user has with UNICAJA BALONCESTO or with any of the companies in its group.

When there is or has been a contractual relationship between the user and UNICAJA BALONCESTO, the user's data may also be processed for the sending of informative and/or commercial communications (*newsletters*), either of its own or of its sponsors, general or personalised, by any means, including e-mail, SMS or any other electronic means of communication.

Legal basis: the processing is necessary for the satisfaction of the legitimate interests of BALONCESTO UNICAJA. The user has the right to object at any time to his/her personal data being processed for this purpose, by communicating this to the following email address: correo@unicajabaloncesto.com.

4. Sending of informative and/or commercial communications. UNICAJA BALONCESTO may request the user's consent to send him/her commercial communications (*newsletters*), of its own or of its sponsors, general or personalised, by any means, including e-mail, SMS, or any other electronic means of communication.

Legal basis: the user's consent.

In any case, the user may oppose the sending of said commercial communications by indicating it in the corresponding box for this purpose or, subsequently, may revoke their consent by communicating it to the following e-mail address: correo@unicajabalconcesto.com.

5. Contact. UNICAJA BALONCESTO may process personal data from users who contact through the website, in order to process their request.

Legal basis: the user's consent.

In any case, the user may revoke consent, so that their personal data are no longer processed by UNICAJA BALONCESTO, by sending an e-mail to the following address: correo@unicajabalconcesto.com.

6. Compliance Channel. UNICAJA BALONCESTO may process personal data from users who report through the Compliance Channel any of the actions or omissions provided for in the current regulations on regulatory compliance.

Legal basis: compliance with a legal obligation in accordance with the provisions of current data protection legislation.

3. Accuracy and truthfulness

The user guarantees the truthfulness and accuracy of the data provided to UNICAJA BALONCESTO through the corresponding forms, exonerating BALONCESTO UNICAJA from any liability in this regard and undertaking to keep them duly updated.

4. Personal data of minors

Children under 14 years of age shall not use the services offered through the website without the consent of their parents or guardians.

In the event that UNICAJA BALONCESTO detects users who may be under 14 years of age, it reserves the right to request such authorisation and/or a copy of their proof of identity.

5. Retention period for personal data

Your personal data will be kept until the statute of limitations has expired for any actions that may arise from the relationship with UNICAJA BALONCESTO, unless there is a legal obligation that extends the aforementioned period of retention.

6. Communication of personal data

UNICAJA BALONCESTO may communicate your data to:

1. The companies in its group for the provision of services, including administration and management services.
2. Competent Public Bodies, State Security Forces and Corps, and Judges and Courts, in compliance with legal obligations.
3. Service providers acting as processors.
4. Unicaja Banco, S.A. as a collaborating bank for the management of subscription payments.

7. Exercise of rights and complaints

The user may exercise his/her data protection rights (access, rectification or deletion, limitation, opposition and portability) by sending a communication to this effect to UNICAJA BALONCESTO by post to Avenida Gregorio Diego, 44, 29004 Málaga or by sending an e-mail to the address correo@unicajabaloncesto.com, indicating in both cases his/her name, surname(s) and attaching a copy of his/her identity document.

Without prejudice to the foregoing, the user has the right to lodge a complaint with the Spanish Data Protection Agency (AEPD).
